

# **Terms and Conditions – Junee Grand Opening Event**

### 1. The promotion

The promotion is the Junee Grand Opening Event 2024 (Promotion).

- The promotion comprises the following promotional activities:
- (a) Discounted fuel offer (Fuel Discount Offer); and
- (b) Free cheeseburger and coffee deal (Free Food Offer).

# 2. The Promoter

## 3. Promotion Period

The Promotion will operate on the following dates/ times:

# 4. Promotion Location

The Promotion will operate at the Promoter's store known as **Bowser Bound Junee** (**Promoter's Store**) located at 1 Illabo Rd, Junee, NSW, 2663 at the dates and times specified in paragraph 3.

# 5. How it works – Fuel Discount Offer

- (a) During the promotion period applicable to the Fuel Discount Offer, up to 60 litres per customer of fuel will be available for purchase at the price of \$0.999 (**Discounted Price**).
- (b) The following additional terms and conditions apply to the Fuel Discount Offer:
  - the fuel discount available with the Fuel Discount Offer extends to all fuel grades and types available for sale at the Promoter's Store during the promotion period;
  - (ii) the Discounted Price is limited to one transaction per vehicle;
  - (iii) the Discounted Price is capped at 60 litres (such that if a customer purchases more than 60 litres of fuel, the alternate price advertised for the relevant fuel type on the fuel bowser will apply to the balance of the purchase);
  - (iv) the discount offer is not available for any transaction made or proposed to be made using Fleet Card, Motorpass or Motorcharge; and
  - (v) all costs associated with redeeming the Discount Offer is the responsibility of the customer.
- (c) The Promoter reserves the right to cancel or suspend the Fuel Discount Offer in whole or in part if the Promoter runs out of fuel.

# 6. How it works – Free Food Offer

- (a) During the promotion period for the Free Food Offer, the Promoter will offer cheeseburgers and a small coffee of any variety (collectively, **Free Food Products**) at no cost.
- (b) The following additional terms and conditions apply to the Free Food Offer:
  - (i) a limit of one of each of the Free Food Products applies to each customer during the promotion period;
  - the Free Food Offer is not available for any delivery orders (including Skip and UberEats);

- (iii) the Free Food Products cannot be substituted for any other product/s on the Promoter's menu;
- (iv) no variations to the Free Food Products are permitted during the Promotion Period; and
- (v) the Promoter reserves the right to cancel or suspend the Free Food Offer if stock of the Free Food Product (or any component part thereof) runs out.

#### 7. Terms and conditions binding

By participating in this Promotion, customers agree to be bound by these terms and conditions. The Promoter's decision in relation to the Promotion is final and no correspondence will be entered into.

#### 8. Limitation of liability

Except for any liability which cannot be excluded by law, the Promoter excludes all liability for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained in connection with this Promotion except to the extent caused by the negligence of the Promoter or its breach of these terms and conditions.

#### 9. Cancellation, modification or suspension

If for any reason beyond the reasonable control of the Promoter, this Promotion is not capable of running as planned, the Promoter reserves the right in its sole discretion to take any action that may be available to it, and to cancel, terminate, modify, defer or suspend the Competition, unless to do so would be prohibited by law.

Without limiting the foregoing, the Promoter reserves the right to cancel, suspend or shorten the Promotion if there is a shortage of fuel or if the Promotion causes or may cause any risk to human health or the environment.

The Promoter reserves the right to cancel, terminate, modify or suspend the Promotion or amend these terms and conditions, subject to any directions from a regulatory authority.

#### **10.** Australian Consumer Law

Customers have rights under the Australian Consumer Law and other similar legislation which cannot be excluded, restricted or modified by the Promoter.

These terms and conditions do not exclude, restrict or limit those statutory rights in any way. To the extent permitted by law, Promoter's liability for any loss is limited, at the discretion of the Promoter, to the replacement of the Free Food Product and/ or fuel purchased via the Fuel Discount Offer (as the case may be) or the supply of equivalent goods to these goods.
